Head Lice Inspections

CHILD/REN _____

The school will be arranging head lice inspections of students. The management of head lice infestation works best when all children are involved in our screening program. The school is aware that this can be a sensitive issue and is committed to maintaining students' confidentiality and avoiding stigmatisation.

Before any inspections are conducted staff will explain to all students what is being done and why, and it will be emphasised to students that the presence of head lice in their hair does not mean that their hair is less clean or well kept than anyone else's. It will also be pointed out that head lice can be itchy and annoying and if you know you have got them, you can do something about it.

The inspection of students will be conducted by Mrs Lorraine Rodger who has been trained by the local council. Mrs Rodger will check through each student's hair to see if any lice or eggs are present.

In cases where head lice are found, she will make appropriate contact with the parents/guardians and provide them with comprehensive advice about the use of safe treatment practices which do not place children's health at risk.

PLEASE NOTE: The law requires that when a child has head lice, the child should not return to school until appropriate treatment has commenced.
